# An “American Mystery Disease”?

In the 1950's, Japan had a “localized” incident where the discharge of mercury-containing waste into Minimata Bay led to the poisoning of tens of thousands to perhaps 200,000 or more of the Japanese people with the compound “methyl mercury” into which the food chain had converted and, in fish, stored the mercury from that waste.

The adults and children consuming the fish were slowly poisoned; fetuses were aborted, and breast-fed babies were poisoned by their mother's milk.

Initially, the Japanese called the problem the “strange” disease and the people who had it were blamed and shunned.

The government and the company responsible for dumping the waste both proclaimed their innocence.

In 2001, Japan's Supreme Court was still reviewing a case involving an additional 51 plaintiffs suing for compensation because the government didn't want to pay the \$2.65 million dollar (US) judgment against it, knowing that paying that judgment would open the government up to an additional 150,000+ similar plaintiffs.

More than US\$240 million was *initially* awarded to those, or their families, who had hair mercury levels greater than 50 ppm *though, subsequently*, a hair level of 10 ppm was deemed to be indicative of damage.

Thus, from the time this “strange” disease was discovered until the government, *who allowed this poisoning to happen*, and the company, *who inflicted the damage*, faced up to the harm and PARTIALLY addressed those worst damaged was more than 50 years.

**They say that those who do not learn from history are doomed to repeat it. The American government and vaccine manufacturers that supply vaccines to America clearly did NOT learn that low-level mercury is an insidious cumulative neuropoison.**

However, unlike the Japanese incident, *where the mercury exposure was hidden in the food some consumed*, the neurodevelopmental disorder epidemic in America seems to have come from the disguised mercury hidden in certain of the vaccines directly injected into the most developmentally **vulnerable** newborns, babies, young children, adolescents, young adults, and, through their mothers, fetuses.

In America, an epidemic rise in neurodevelopmental disorders was first noticed in the late 1990's.

As with the Minimata incident, the American government and the drug industry have, as yet, found no proven cause for this “American Mystery Disease.”

Again, the victims and their parents have been blamed — bad parenting, bad genes.

Again, the government and the industry have secretly conspired to debunk, using the tried and true, there is no proof that “A” (mercury and/or aluminum and/or the live viruses in vaccines and/or vaccines themselves) has caused “B” (this “American Mystery Disease” epidemic).

Moreover, *like Japan*, the American government has neither vigorously sought the cause of this disease nor provided any scientifically sound definitive studies that have proved that the cause is not mercury, aluminum, or the viruses in certain vaccines, or the vaccines themselves.

*Unlike Japan*, **the harmed** are not confined to the hundreds of thousands but **reaches into the tens of millions**.

If, as a growing body of evidence indicates, the major cause of the epidemic rise in neurodevelopmental disorders is the mercury (from Thimerosal through ethyl mercury into ionic mercury) accumulating in the brains of our children, the government and the vaccine industry will have participated in the harming, *to some degree*, of every child inoculated with a vaccine containing Thimerosal as a preservative and, perhaps, *at a lower level*, every child receiving today's euphemistically labeled “Preservative free” vaccines that factually contain lower levels of this mercury compound.

In 1999, the government and the drug industry jointly pledged to remove Thimerosal from Thimerosal-preserved vaccines as soon as possible.

*Five years later*, not only has this NOT been done but also, *to cover up the presence of the mercury*, reduced-Thimerosal vaccines are labeled “Preservative free” and the public has been repeatedly falsely told their vaccines contain no mercury!

.....Worse, the government and the vaccine industry have conspired to introduce a questionable “flu” vaccine into the childhood vaccination schedule even though most of the available “flu” vaccine doses are “Thimerosal-preserved.”

Given the evidence of the harm that the subacute administration of vaccines containing mercury may be inflicting on our children, no vaccine that has been proven or is known to provide less than “herd immunity” (defined as greater than 80% of those immunized) that contains any level of Thimerosal should be allowed to be administered to any pregnant woman, developing child, or young adult under the age of 25, the age at which higher-order brain development is generally completed.

Moreover, given the growing body of evidence of harm to 1 in 6 children, no Thimerosal-preserved vaccine should be permitted to be administered to any person.

The sooner we remove the most probable cause of harm, the fewer will be irreversibly injured and the lower the overall cost to society — hopefully, today is the day we start this journey!

.....Already, the conservative cost estimates for ONLY those most seriously damaged by this “American Mystery Disease” exceed \$2.2 trillion (million million) dollars (\$2,200,000,000,000).
